**1. RAFFLE NAME**

**2. PROMOTER**

The MCCF EV Mini Car Raffle will be conducted by Modern Classic Cars Foundation Ltd, ABN: 96 683 064 735 of 2/361 Milperra Road Bankstown Aerodrome NSW 2200. The benefiting organisation is Modern Classic Cars Foundation, a not-for-profit organisation with ACNC charity approval status.

**4. RELEVANT STATES**

**Entry is open** to residents of the following State(s) aged 18 years or older at the commencement of the Raffle:

- New South Wales (NSW)
- Victoria (VIC)
- Queensland (QLD) – Limited to a maximum of 500 tickers in QLD

Residents of the following States/Territories are **not permitted** to purchase tickets in the raffle and are not eligible for any prizes:

- South Australia (SA)
- Western Australia (WA)
- Tasmania (TAS)
- Australian Capital Territory (ACT)
- Northern Territory (NT)

## **5. RAFFLE PERIOD**

## **7. MAXIMUM NUMBER OF TICKETS**

5000 tickets will be available for purchase at \$100 each.

The raffle will close at the end of the Raffle Period or when all tickets are sold, whichever comes first.

## **8. MAXIMUM NUMBER OF ENTRIES**

No maximum number of entries applies. Participants may purchase as many tickets as they choose while the Raffle remains open, and tickets are available.

## **9. ENTRY RESTRICTIONS**

Entry is open to residents of the Relevant States(s) aged 18 years of older at the time of purchasing tickets to the Raffle.

The following people are not eligible to enter and are not eligible for any prizes:

- Members of the Management Committee or Board of Directors from the organisation conducting the raffle or benefitting from the raffle
- Employees of Modern Classic Cars Foundation
- Employees and Contractors of RaffleLink
- Any other person directly engaged in managing the Raffle or conducting the draw
- Any immediate family member of any of the above. Immediate family means a person's spouse, parents, children and any other family members residing at the same premises as the person.

## **10. VERIFICATION REQUIREMENTS**

#### **16. UNCLAIMED PRIZE ARRANGEMENTS**

#### **17. CANCELLATION OF RAFFLE**

The Promoter reserves the right to cancel or withdraw the Raffle before the draw of the Prize.

If the Raffle is cancelled prior to the Draw, the Promoter will make all reasonable attempts to refund the purchase price for the Raffle Ticket to the Entrants. Where an Entrant is uncontactable and the Operator has not been able to refund the purchase price after conducting reasonable attempts, the relevant Entrant is deemed to have foregone its right to a refund.
